## APPROVAL OF MEETING MINUTES

MOTION: A motion was made to approve the October 16, 2009, meeting minutes. The motion was seconded and carried.

## **RATIFY ADJUSTMENT LEVEL OF REVIEW FOR 2010 REPORTS**

Mary Welsh briefed the Commission on adjustment to the level of review of the Food Processors Sales and Use Tax Deferral/Waiver. Based on updated Department of Revenue data, JLARC staff recommended moving the level of the tax preference review from Full to Expedited.

The Commission found sufficient consensus to ratify adjusting the level of review for the Food Processors Sales and Use Tax Deferral/Waiver.

#### **STAFF REPORTS / UPDATES**

Ruta Fanning provided an update on the newly created Task Force on Tax Preference Reform.

Mary Welsh and Dana Lynn provided a recap of legislative actions on prior tax preference reviews.

## PROPOSED 2011 10-YEAR REVIEW SCHEDULE

Mary Welsh and Dana Lynn presented the proposed 2011 10-Year Review Schedule.

The Commission discussed the review schedule, concentrating on the Expedited Light reviews. Chair Longbrake requested that for the September meeting staff make available the information provided by the Department of Revenue on tax preferences scheduled for Expedited or Expedited Light review in 2011.

## 2010 PRELIMINARY TAX PREFERENCE REVIEWS

Keenan Konopaski, Mary Welsh, and Dana Lynn presented the 2010 Preliminary Tax Preference Performance Reviews. The presentation focused on the nine reviews with staff recommendations involving legislative action, or acceptance of expiration dates. The Commission also discussed the 11 reviews where staff recommended continuation and the 38 tax preferences in the Expedited Light report.

## PUBLIC COMMENT

Sean Eagan, representing the Port of Tacoma, testified regarding taxation of interstate transportation.

With no further public comment Chair Longbrake adjourned the meeting at 5:15 p.m.
